**Producers should complete the application & return to Grayson County Extension Office at 64 Quarry Road in Leitchfield by Tuesday, April 30<sup>th</sup>. Applications turned in after the deadline will be \$35.** All applicants will receive either an approval or disapproval letter in the mail letting you know the status of your 2024 Farmers' Market Application. Those who are approved will receive a "2024 Farmers' Market of Grayson County Vendor Certificate" this will need to be displayed when you set up during the 2024 season along with other training certificates you have. This will work as your proof of approval.
